Board Meeting November 29, 2021 VIA Conference Call

MINUTES

I. Call To Order

The meeting was called to order by Dr. Dean Sprinkle, President at 2:05 p.m. Dr. Sprinkle welcomed all the board members and thanked them for their attendance and their service.

II. Approval of the May, 2021 Minutes

Dr. Patricia Lee moved to accept the minutes of the May 4, 2021 Board meeting. Dr. Cynthia Kelley seconded the motion. The minutes were approved unanimously.

III. Board Officers and Members

Dr. Edwards referred the board to the attachment listing all information related to the board and officers. If any corrections need to be made, please let Dr. Edwards know.

IV. Membership Report by State

Dr. George Edwards reported on membership by state. As of November 1, 2021, 162 members had paid. A few more were anticipated to pay before the end of the year. The budget was based on 170 members. It appears that membership for 2021 will be down slightly from the final count in 2020 (167).

V, VI, and VII. Investment Report, Budget to Actual 2021, and Report of the Audit Committee

Dr. Edwards requested that the Audit Committee deliver its report since much of the information they would present would be identical to that in the Investment and Budget to Actual Report listed on the Agenda. Dr. John Enamait, member of the Audit Committee was asked to present

the report. Dr. Enamait and Dr. Patricia Lee met with Dr. Edwards via conference call concerning the finances of the association. Dr. Campbell was unable to participate in the call with Dr. Edwards. The Committee was provided with a booklet of information which included:

- 1. The cash-investment report. (Attachment 4)
- 2. A budget to actual spreadsheet showing income and expenses to date and estimated through the end of the year. (Attachment 5)
- 3. A summary of charges/withdrawals up through November 1. (Attachment 6)
- 4. A complete set of bank statements for each month through October. (Attachment 6)

A summary of the report follows:

- 1. The association is in sound financial position with total cash and investments of \$159, 607.37 as of November 1. Two CDs are on deposit with maturity dates of May, 2022 and June, 2022 respectively. The interests earned on all accounts is estimated to be \$1,500 for 2021. The CD that matured in May, 2021 at an interest rate of 1.56% was rolled over to a one-year CD with an interest rate of .3%, still a greater interest rate than a savings account.
- 2. It is projected that the association will have a net income for the year of \$2,646.38 due to the following:
- A. Membership is currently down slightly from 2020. We will likely be close to the 2020 level of 167 members by our spring meeting.
- B. We had no revenue from sponsorships or from luncheon ticket sales given the decision by SACSCOC to hold their meeting in a virtual format.
 - C. Interest income is projected to be slightly lower than what was budgeted.
- D. Total expenses will be less than the budgeted amount of \$36,250 by approximately \$9,500.

Dr. Ingrid Thompson-Sellers seconded the motion made by Dr. John Enamait, on behalf of the Audit Committee, and the Investment Report, the Budget to Actual 2021 Report and the Report of the Audit Committee were all unanimously approved by the Board.
