Call to Order. Juliet V. Garcia, President

- I. Approval of Minutes. The minutes of the December board meeting were adopted with corrections.
- II. Management Sub-Cycles. Management sub-cycles were distributed to all Board members by Marilyn Beck.
- Treasurer's Report. After a lengthy discussion, III. the Treasurer's Report was approved. The Treasurer distributed a listing of member colleges indicating whether or not each college had paid 1989 dues of \$35. The Secretary will draft a letter citing the advantages of SACJTC membership and will print a mailing list by state of the colleges that have not paid 1989-1990 dues. Each board member will receive a copy of the letter and the mailing list of his/ her state. The Board member is to then contact each college and request payment. Ron Horvath should receive the Kentucky list, and Barry Mellinger should receive the Louisiana list. The Secretary should write to two-year colleges not on the SACJTC membership list and invite them to join.

On July 1, the Secretary will send bills for 1990-1991 dues of \$50; the President will write a letter to accompany this billing. A second notice will be sent November 1, if necessary.

- IV. Report of the Editor. Tickets for the Annual Meeting will be offered for sale in the Fall Newsletter; therefore, the Editor's Management Sub-Cycle was modified. The Secretary will notify each Board member of those in his/her state who have purchased tickets. The Secretary's Management Sub-Cycle was also revised.
  - A. Spring Newsletter Articles for the spring newsletter are due by the second week in April. Articles featuring DeKalb College and Sparks Technical College will be submitted by Marvin Cole and Linda Wilson. The "Spotlight on a Leader" will feature John Teel. The newsletter will include a message from the president and a financial statement. Presidents retiring from member institutions will be asked to notify the Board President. A listing of Board members will be included if space is available.
  - B. Fall Newsletter The fall newsletter will feature the December meeting. Tom Barton will be spotlighted as a leader. The Editor will identify a college to be highlighted. Presidents retiring from member colleges will be asked to notify the Board President.
  - C. Occasional Papers Dennis Johnson will author an Occasional Paper on marketing in the community college. Karen Bowyer will write an Occasional Paper on assessment.

  - A. Nominating Committee Barry Mellinger (Chairman), Marvin Cole, and Linda Wilson were appointed to serve on the Nominating Committee.
  - B. Auditing Committee Rudy Groomes (Chairman), Jim Richardson, and Marvin Cole were appointed to serve on the Auditing Committee.

The Nominating Committee will report at the December Board Meeting, and both committees will report at the Annual Business Meeting.
